This service is now chargeable at £35 for the first bin & £30 for any additional bin. The uptake has been overwhelming. A policy was approved in March and I am concerned that religious buildings are now chargeable & shall hopefully have this reversed.

Enforcement which is related to Planning has undergone a revised policy & better resourced but it is under pressure.

Leisure Contract

This is being reviewed and a new package rolled out which means that Market Rasen is to benefit with a site, and the leisure complex at Gainsborough transformed. One great benefit is an 'outreach' programme to help and support 'wellbeing' for all ages in our community spaces across the District.

The changes have come in for adverse criticism in the press from one causality – the bowls club which meets for a limited period of the year at the Gainsborough Centre. WLDC has in my opinion 'fallen over backwards' to help and support the club as it looks for an alternative site for its activity. The officer responsible for oversight has come in for a barrage of abuse which is not justified and has not been provoked. There is no way this new contract will be reversed as it will jeopardise the vision we have for a more inclusive leisure wellbeing service for the District.

Planning Application/s

I do not intend to steal your Chair's thunder on the matter of Corringham School, however, I did submit my comments personally and also in writing to the Planning Officer in which I supported the comments made by your Council. Last time we met, there was a notification about screening for a solar farm in the parish. Initially the actual location was not given on the papers however the actual location is off Pilham road at the entrance to Northfield Farm. Mr Riddle owns two sections of land either side of the drive to that farm and it appears his intention to create a solar farm on that land. Mr Riddle is yet to submit a planning application for a solar farm.

Neighbourhood Plan/ Northern Extension Exhibition:

I attended the exhibition on Tuesday 27 March and duly volunteered to be part of the Corringham Neighbourhood Plan Group and look forward to working alongside its members.
