County Councillor

County Cllr. Perraton-Williams gave the following report:

- The drains near Aisby have been cleared and the 'Aisby' sign has now been turned around and is now facing the correct way.
- The gullies are to be cleared out this year.
- The street light column on Mill Mere has been fixed.
- County Cllr. Perraton-Williams had recently had a meeting with the Head Teacher of Corringham Primary School regarding school parking and informed members that the Head Teacher would be willing to attend a public meeting to discuss the on-going parking issues. The meeting could be arranged to take place before a Parish Council meeting. The Parish Council agreed to this and Cllr. Perraton-Williams agreed to progress.
- Cllr. Perraton-Williams confirmed that she had secured funding to carrying out the necessary work on the Corringham Road junction.
- There is a opportunity for members to be trained to become part of the community speed watch initiative.

District Councillor

District Cllr. Howitt-Cowan gave the following report:

- PA 138994 – single storey side extension (Park Farm, Yawthorpe Lane) has today been published. But, as yet, no details are available
